H. Bill Breakdown:

Service Availability Charge- The Service Availability Charge is a flat monthly fee on your electric bill that covers the fixed costs of maintaining and operating the electric grid to ensure electricity is available to you, regardless of how much you use. **This charge has always been included in your bill**, but it is now shown as a separate line item for transparency.

Energy Charge- Usage of up to 900 kWh will be billed at \$0.10302 per kWh.

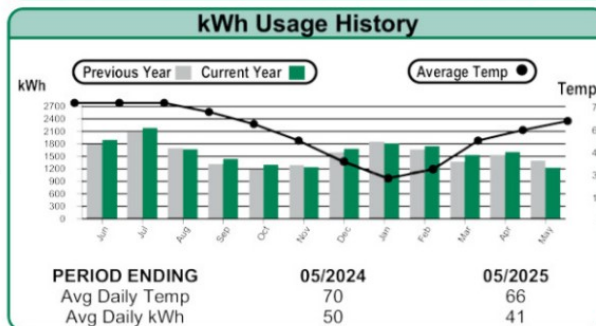
Energy Charge- All usage exceeding 900 kWh will be billed at a rate of \$0.09987 per kWh. A second Energy Charge line will appear on your bill only if your usage exceeds 900 kWh.
